## AGREEMENT

Made and entered into between:

The parties agree as follows:

1. Phd4toddlers hereby grants to the school the right to utilize the program, name and logo of Phd4toddlers on its premises.
2. The duration of the agreement shall be of effect and binding for a period of THREE YEARS commencing on ..... 20.. until ..... 20.....

### 3. PERSONNEL.

The success of the program is only as successful as the presenter of the program. Motivated personnel, WILL make a difference to the toddlers life and motor skill development by using this program.

### FINANCIAL ASPECTS

The school shall be liable to pay to Phd 4 toddlers an amount equal to one toddlers, full day, monthly fee, per month. There is a minimum fee of R1000 (one thousand rand) per month payable.

This amount is payable on a monthly basis.

The first payment will be done electronically on the day of delivery.

The contract will start effectively on the day the first payment have been made.

The school hereby undertakes to effect payment of the amount stated herein by way of debit order, payable on the 25th day of each calendar month.

Payment by way of EFT is not acceptable.

Interest on arrear amounts due will be charged at a rate equal to the prime-lending rate on overdrawn accounts by FNB Bank

The equipment to be used is supplied by Phd4toddlers and as such remains the property of Phd4toddlers.

## 5. TERMINATION

On completion of the three year period, the program becomes the property of the school.

The school shall upon demand pay all monies due to Phd4toddlers, including amounts due in terms of this agreement, damages, costs, expenses, interest and reasonable legal fees, if the school should terminate the agreement before the three year period that has been agreed upon.

All equipment shall without delay be returned to Phd4toddlers.

## 6. DISPUTES

Disputes shall be settled between the parties in accordance with normal business practice. Should any party however be of the opinion that the handling of the matter is not conducive to a resolution being reached, such a party shall be entitled to refer the dispute to arbitration, which arbitration shall be in accordance with this clause.

Should a court of competent authority make an order that any clause or condition contained herein are invalid or should be set aside, the remaining conditions hereof, not affected by such order shall continue to be in force.

This agreement may only be amended by written agreement between the parties and signed by both parties or their duly appointed representatives.
